DESCRIPTION

PMP® Concrete Dissolver is a liquid compound specifically formulated to dissolve built up cement on tools and equipment associated with the concrete ready mix and masonry industry. PMP Concrete Dissolver is 100% biodegradable, non-corrosive and will not cause rust or corrosion. It is safe to use on metals, equipment, wood, glass or painted surfaces.

USES AND BENIFITS

- Use PMP Concrete Dissolver to safely clean, dissolve and remove concrete, cured cement, mortar, grout and stucco.
- Use to clean trowels, screeds, hand tools, mixers, pumps, scaffolds, mud tubs, mud boards, trucks, trailers and silos, saws, drills, generators, augers and more.
- May be used to etch concrete and open the surface pores in preparation for decorative coatings.

PACKAGING

22 oz (380 ml) spray bottle

APPLICATION REQUIREMENTS

- PMP is water-neutralized. Never wet surface with water before applying.
- Protect walls and adjacent areas where dissolving is not desired.
- DO NOT dilute PMP Concrete Dissolver.
- DON NOT USE ON CONCRETE PAVERS

APPLICATION

1. Completely saturate area of hardened concrete, mortar or stucco to be removed with undiluted Concrete Dissolver.
2. Surface will turn white on contact then darken. White residue may appear if Concrete Dissolver evaporates.
3. Do not rinse. Re-apply to reactivate as needed until concrete has softened and dissolved.
4. Allow Concrete Dissolver to penetrate for 10 - 15 minutes. Then re-apply to the same area. Keep surface wet with Concrete Dissolver.
5. Concrete will soften and release from surface after approximately 20-30 minutes.
6. Rinse with cold water using a garden hose with a pressure nozzle, or use a high pressure washer.
7. On extra thick build up, repeat cleaning directions until build up has softened.
